


# WEST DALLAS SCHOOL DISTRICT

boundaries of incorporation



People living in West Dallas opposed inclusion into a *City of Oak Cliff* as originally incorporated in 1890. After the courts annulled that municipal boundary, Oak Cliff had a second vote and incorporated a smaller area in 1891. The next year West Dallas formed its own corporation as a school district, and drew its own boundary. The court annulled that incorporation. West Dallas then had a second vote which established their school district in 1893. In 1914 the West Dallas school district added a mile to its west; and, in 1916 it added all the area north to the Trinity River's main channel and West Fork. West Dallas never incorporated itself as a city.

Since the West Dallas District boundary location uses this 2<sup>nd</sup> City of Oak Cliff boundary, I spent time trying to reconstruct that second incorporation outline. What is shown on this *Sam Street's* map detail is generally correct for those city limits of 1891, but a more detailed map and discussion are attached below.



Attempting to reconstruct these city limits from the verbal description established in the Dallas County deed records (cited above), I gave up after stumbling to find the third corner point. That point is described as: "Thence South to the north side of a tract of land sold by J.W. Hill and wife to T.A. Hord."

To find that 1891 property line the following research was necessary:

(1) 1889-October 8th, Dallas Co. Deed records, Vol. 109, page 293 -- 28 acres from Hill to Hord. Instead of metes & bounds description, this deed references prior deeds, which are: (2) 1887-January-1st; where H. Hart sells 30 acres ("off the west end of 80 acres") to Hill; Vol. 75, p. 592. Also needed is: (3) 1887-June-2nd, Vol. 87, p. 82, whereby Hill then sells 2 acres out of the 30 acre tract to Valles. (4) The deed of 1875-June 29th, Vol. 30; page 792, describes the location of the 80 acres sold by H. Hart to Work, with enough definition so that the site can finally be located. As I calculate it, the "north side of the tract sold by Hill to Hord" is ~722 feet wide (east-to-west) starting on the west boundary line of the G.S.C. Leonard Survey, ~1809.3 feet north of the G.S.C. Leonard's Survey's S.W. corner.

I could never get this third point to align assuredly with the description's second point, which I also had trouble locating, so I then gave up on my reconstruction of the 1891 incorporation city boundary of Oak Cliff.

I will note however, that I believe that the above outline shown by Murphy & Bolanz in 1891 is more nearly accurate than the corresponding city limit outline shown on the 1905 map Worley's: *Greater Dallas Texas*.
